- Families must notify the school in writing if a student is withdrawn from the school. Tuition obligations by the parents are as follows:
- Registered students who withdraw before the first full day of school are responsible for ¼ of the full tuition amount and all fees.
- Registered students who withdraw between the first day of school and December 15th are responsible for ½ of the full tuition amount and all fees.
- Registered students who withdraw after December 15th are responsible for the full tuition amount and all fees
